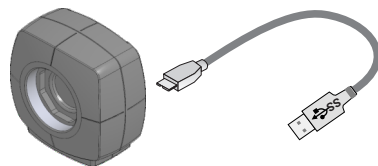

Install a software that supports the USB3 Vision protocol to operate the camera.

Connect the camera



On connection, the driver installation starts automatically.

LED flashes green 3x/2x: USB 3.0/2.0 port detected.
LED green: Driver is loaded. Camera ready.

PCB version only: Make sure to avoid mechanical or electrical damage of the printed circuit board or its connections.

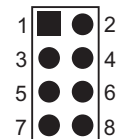
Option: Change between USB3 Vision and IDS Software Suite
